

## Are your clients on the CBI (compulsory BVD investigation) list?

The ScotEID website lists all CBI (Compulsory BVD Investigation) herds. This list is only visible to certain users, including the ScotEID Helpline Team, vets and Local Authorities. Keepers can log into their ScotEID account to view their own BVD testing and their own notification of CBI, if applicable.

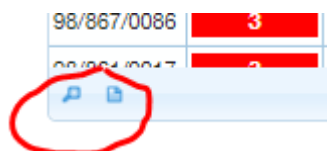
If your clients are in a CBI, they may ask your advice on BVD testing and what the requirements are to get the CBI completion certificate signed off. Some vet practices choose to be proactive, and contact their own CBI clients to prompt a review of their BVD testing. ### How to find the CBI list on the ScotEID website

Log in to ScotEID and click on “CBI holdings” on the Cattle menu:



Use the “download” or “search” buttons at the foot of the CBI holdings table to sort through the table and find your clients’ herds:



The herd’s CBI status shows as either ‘active’ or ‘complete’:

**Active** – herd has entered CBI and must either get a BVD status for every animal (option 1) or be removed from the CBI by an approved vet (option 2) (see separate document [“Signing the CBI completion certificate”](#) for more information).

**Complete** – herd has got a BVD status for every animal AND an approved vet has certified that all animals in the herd have an Individual Negative\* result (option 1). The keeper must now do a year of follow-on calf testing.

### How do farmers know that they are in a CBI?

CBI information is stated at the top of the herd record on the ScotEID website. Farmers who log into ScotEID to check their BVD records will see this.

The following advisory letters are sent to the keeper:

- Approaching a CBI – herd has been continuously Not Negative for 13 months.
- Entered CBI – herd is still Not Negative two months later, at 15 months.
- Nearing the CBI completion date - herds that have still not resolved their CBI after 12 months of entering CBI.

If the CBI herd still has animals without a BVD status after 13 months, it is non-compliant. A breach letter is sent to the keeper and their Local Authority for enforcement action.
