This is a small group (8 maximum) one day online training course suitable for all vets wishing to learn more about the MilkSure course, and how to deliver the training to dairy farmers. Vets working in industry and academia are very welcome, as well as practitioners.

The training includes lots of discussion and covers:

- 1. Technicalities of milk residue failures
 - testing methods and industry procedures
 - legislation
 - discrepancies between MRL's and testing sensitivities
 - · cascade use of medicines
 - vets' legal responsibilities, including when medicines are used under the cascade (offlabel)
 - likely changes on the horizon
